Organization Information

Overview

Aeromedical Legal Assistance ("AeroMed Legal"), is a legal aid organization that provides guidance and support to individuals navigating the aeromedical certification process. Services cater to student pilots, general aviation pilots, and pilots who lack the benefit of a union's Aeromedical Committee, offering assistance with aeromedical certification, medical records review, legal consultation, flight training support, and no-interest aviation medical loans for more in-depth medical evaluations. With a focus on low-income customers, AeroMed Legal aims to provide affordable and accessible resources for those pursuing a career in aviation, or those that might otherwise be unable to pursue their goals of becoming a career pilot.

Financial Needs

For operation, securing donor funding is critical. Initial funding requires \$5,000 to kickstart operations. Through our online platforms and remote access channels, AeroMed Legal is poised to connect with pilots nationwide, ensuring our services reach those who need them most. With a comprehensive suite of offerings tailored to diverse market segments, the AeroMed Legal Board of Directors is optimistic about the organization's prospects for financial success. Financial Budget

The bulk of funding is used for professional liability insurance for volunteers and attorneys, a website, government filings, and a phone line, and other marketing materials. For the 2024 Fiscal Year, the table below represents these planned expenditures.

Director, Officer, Member, and Other Individual Contributions

Members of the board of directors have invested a combined total of \$2,000 for FY2024. Currently, officers of the organization serve in a concurrent capacity as board members. Thus, there are no separate funding contributions for officers. Moreover, Aeromedical Legal Assistance, Inc., is not a membership organization; it does not receive funding from members. There are no in-kind contributions from any class of managers or members to report for FY2024.

Donor contributions enable us to develop and sustain vital programs, such as our peer connecting initiatives and medical evaluation loan and scholarship programs, which play a pivotal role in promoting mental health awareness and accessibility in the aviation industry. By leveraging the generosity of our supporters, AeroMed Legal can amplify its impact, foster positive change, and empower aviators to pursue their dreams with confidence and resilience.

Corporate Contributions

Public Law 104-134 requires that donors be advised that Aeromedical Legal Assistance, Inc., may be funded in part by the Legal Services Corporation. Additionally, Aeromedical Legal Assistance, Inc., may be funded in part by donations from corporate sponsors or other entities. Currently, there are no corporate contributions under this section to report for FY2024.



AeroMed Legal Scholarship Fund

AeroMed Legal is developing a program that will identify individuals in the general aviation community with specific need for expensive FAA required evaluations and will allocate funding to these individuals for these evaluations. Initially, the program will generate a loan for up to 80% of an airman's neuropsychological evaluation or psychiatric evaluation, which cost on average \$4500 and \$3000, respectively. This funding will come from financial donations to AeroMed Legal in excess of the operational budget in Part II, above.

Details are currently in development. However, funds for this program will be paid from AeroMed Legal directly to the medical provider of a pilot's choice. The pilot will then be required to pay the balance of the loan, without interest, to AeroMed Legal only after successfully passing a CFI practical test or finding gainful employment in the aviation industry. The funds used to pay the balance will then be re-pooled in the program fund to allow for use by other needs-based individuals.

In the event that an airman is unable to secure medical certification from the FAA, the balance of the loan will be forgiven, effectively creating a needs-based scholarship for those individuals.

All donations are tax-deductible absent any limitations on deductibility applicable to any particular taxpayer. No goods or services are provided in exchange for any individual's contribution.
